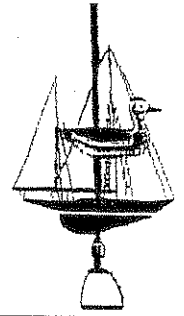

## *From the President:*

Hello Ulmstead! Since last month's message there has been an earthquake, a hurricane, and a tropical rain deluge. What's next, locusts? At least the lawn mower guys have been able to make big money this summer. The tree removal companies also have had a good run as it seems the oak forest in the older part of Ulmstead is slowly yielding to the forces of nature and flattening a few of our personal possessions in the process.

The guys "Beer and Brauts" event is scheduled for October 21st so call in your RSVP and don't be left out. Halloween is on a Monday this year so be aware that candy-collecting is the kid's priority, not safety, and some of their costumes limit their vision so keep a sharp eye out for them.

So much for the fun stuff. Your Board has been working on funding issues regarding UCI recapitalization in general and the Dock II rebuild in particular. Over the years, UCI has spent its money improving the assets that it owns. We have done many projects such as sprinklers and air conditioning at the Barn, a rock jetty at the spit, increased dock area at Dock II, and expensive playground equipment at the Beach. All these things and more have been done to enhance the experience of living in Ulmstead. However, as the value of the amenities has risen, so has the long-term cost of replacing them. Wood rots, paint peels, mechanical systems wear out, and even plastic hardens and cracks due to sunlight. As a community, we have tended to avoid a hard look at our finances. That is why your Board has undertaken a professional reserve study of UCI assets to see where we stand compared to where we should be regarding cash reserves. I am sure many of you are thinking that this may result in a hit to your pocketbook. You are right. This economic situation we are experiencing is a poor time to broach this subject. Right again. The Board has come to the conclusion that we have kicked this particular can down the road long enough and we have to face some hard facts.

Please put the dates for the following meetings on your calendar:

- DOCK II FUNDING PRESENTATION on October 15, 2011 at 9:00 a.m. at the Barn. This meeting will be for answering questions the community-at-large may have regarding the Board's approach and will hopefully keep the November Budget Meeting from becoming an all-day affair.
- UCI ANNUAL BUDGET MEETING on November 12, 2011 at 9:00 a.m. at the Barn. This is when the community will vote on the Budget as developed by the Treasurer and vote to approve or disapprove the Board's plans for recapitalization of UCI assets. There will be a vote on a 5 year assessment schedule to help fund Dock II replacement.

## Report on the Dock 2 Replacement Project

This document is an update on the Dock 2 Replacement Project to all UCI members. Members are encouraged to attend a detailed presentation on the status of this project to the community on **Saturday, Oct. 15 at 9:00 am** at the Barn. This meeting will be your best opportunity to ask questions and join in discussions on options for the project.

As you may have surmised from the updates in the Weathervane for the last year, the UCI Board will be requesting a special Capital Assessment starting in 2012 from all UCI members. The purpose is two-fold. The immediate need is to begin accumulating capital to finance the Dock 2 project, as we are working towards a plan to complete construction over Winter 2013-2014. However, equally as important is the longer term need to accumulate capital as a community for the UCI General Capital Reserves, in order to meet the inevitable recapitalization requirements of other community assets. Although discussions regarding a Capital Plan for the community have been held before, no action has ever been taken to understand the capital reserve requirements and develop strategies to fund those future requirements. We have contracted Miller-Dodson, a company specializing in community reserve studies, to analyze our assets and tell us what reserves are necessary to properly maintain all UCI amenities in good condition. We hope to have the study available at the October meeting to help our membership better understand UCI's fiscal health.

UCI Members are strongly encouraged to attend the 2012 Budget Meeting on **Saturday, Nov. 12 at 9:00 am** at the Barn. The UCI Board will present the 2012 Operating Budget for membership approval, along with a proposed Special Capital Assessment. We need a quorum of members for the meeting, and are looking forward to an *informative, productive* and *civil* discussion about the future of UCI's capital assets, most urgently Dock 2.

### Goals for Dock 2 Project

The goal for this project is to replace Dock 2 on a planned schedule. We are trying to balance the number of useable slips, better protection for boats from waves (weathering improvement) and total cost and timing within the constraints of permitting requirements, technical issues, and financing ability, to minimize risk of losing access to UCI's primary revenue-generating asset. We feel it is important to pay for the project in a way that demonstrates fairness to Nautical Facilities users and the broader UCI membership.

### Dock 2 Committee

Over the last eighteen months a group of UCI members has labored to come up with a Dock 2 recapitalization plan that hopefully would be acceptable to the community-at-large. In a nutshell, that

plan is to replace the entire Dock II and finance it with a combination of funding sources. First, in anticipation of the need for replacement of Dock 2, a slip fee increase of 15% per year began in 2010 and will continue until the year 2014 in order to accelerate the accumulation of nautical department cash reserves . Second, a special community assessment of approximately \$300 per year (in addition to the current \$225 yearly dues) will be implemented for a period of five years starting in 2012. To make the Dock II replacement possible in the Winter of 2013-2014 a bridge loan would be taken out from an outside lender. This loan would be repaid as quickly as possible from the income from slip fees and the community assessment. Without the financial help of the community, there is no feasible solution to this situation. The community funding of the Dock II is anticipated to be a one-time requirement and will allow the Nautical Department to accumulate the funds from slip fees to replace Dock I and Dock III as needed and accumulate a reserve for the future replacement of Dock II in approximately 35 years.

#### October 15<sup>th</sup> Meeting Agenda

The Board realizes that the current economic situation makes this a challenging time to ask residents for a large increase in their cash support for UCI. Unfortunately, the financial issues we are facing are a long time in the making and the current Board is faced with very difficult decisions that can no longer be avoided. At the upcoming October meeting we will lay out in detail what the dock committee and the UCI Board are proposing. This meeting will be your opportunity to have input and express your opinion. We will try to explain the details and conduct a straw vote in order to inform the final UCI Board proposal to the community membership in November. This is the culmination of the selfless efforts of a lot of smart volunteers who have given this their best shot. No solution is going to be perfect and not everyone is going to be satisfied. But, at the end of the day, we all moved to Ulmstead at least in part because of the water amenities and to let them deteriorate would not only negatively affect our property values but would negatively affect our quality of life. Finally, what we have learned from this process is that the challenges facing the community are NOT just about Dock 2, but the greater capital reserves required to maintain UCI as the sought after community that it is, well into the future

#### UCI Community Decisions

According to our By-Laws, the community must approve all capital projects, special assessments, as well as the borrowing of money for community projects. At the November Budget Meeting, community members will be asked to vote on these extremely critical decisions for our community. Please plan on attending this important meeting because your vote is necessary and important whether you are in support or against these recapitalization plans.

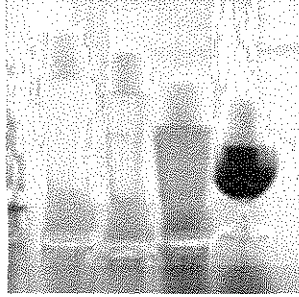

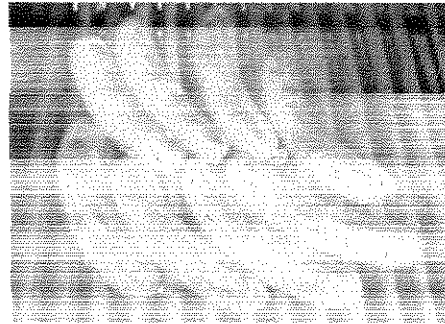
